

# Rules of the Hannes Androsch Prize

(12.6.2008)



## 1. Background

The Hannes Androsch Prize, established in 2007 by Dr. Hannes Androsch, will be awarded by the Hannes Androsch Foundation at the Austrian Academy of Sciences.

## 2. Conditions

There are no restrictions on eligibility.

## 3. Scientific Area

The Hannes Androsch Prize will be awarded for an outstanding written work, a scientifically based article in the social sciences field.

## 4. The Prize

The Hannes Androsch Prize will award an amount of money which is going to be announced in newspapers and on the website of the Austrian Academy of Sciences. Apart from this award the Hannes Androsch Foundation will not pay any expenses to applicants.

## 4. Selection of Laureate

1. The Scientific Committee of the Hannes Androsch Foundation, which comprises exclusively of members of the Austrian Academy of Sciences, will appoint an ad hoc committee of eight academic members with the Vice-President of the Academy as chairman. This committee will select a short list of the best submissions from all received and also appoint an International Jury.

2. The International Jury will comprise five members who will independently determine how to arrive at a decision regarding the choice of laureate.
3. The International Jury will, at least two months prior to the planned award ceremony, convey both its decision and the written justification for this decision, which will be read at the Prize ceremony, to the chairperson of the Hannes Androsch Foundation. The jury can also decide that no work worthy of the Prize has been submitted.
4. The activities of the International Jury are concluded with either the selection of a Prize winner or with the decision that, due to the lack of a worthy work, that the Prize will not be awarded.
5. The award ceremony, in accordance with the guidelines of the Hannes Androsch Foundation, will be held in Vienna.

## **5. Application Procedure**

1. Written Work

Applicants must submit an outstanding written work on the topic of the Prize.

2. Language

German and English

3. Publication

With the submission of a written work, the applicants agrees to the following conditions if awarded the Prize:

- a. The applicants transfers all rights of use to his work exclusively to the Austrian Academy of Sciences publishing house, which, according to the principles of Open Access, will publish the work in both paper and electronic form. With the awarding of the Prize, all potential claims which arise or could arise from any possible exploitation of the work awarded the Prize, in particular in its entirety or in shortened or modified form, are satisfied.
- b. The applicants will participate in the public award ceremony on the date to be decided by the Hannes Androsch Foundation. Reasonable

travel and accommodation costs will be borne by the Hannes Androsch Foundation.

- c. The applicant<sup>s</sup> accepts the decision of the international jury under preclusion of the due process of law.
2. Documents to be submitted: Together with the work, the following documents are to be sent to the Prize Committee:
    - a. Completed Application Form
    - b. The manuscript with a summary
    - c. Curriculum Vitae
    - d. Presentation of scientific accomplishments
    - e. List of Publications
