Main areas of research and short statement of the most important research results achieved to date

Arno Strohmeyer researches pre-modern politics based on cultural as well as anthropological theories and methods. He specifically analyses the historical dimensions of current problems to provide science-based orientation knowledge for the present. This can already be seen in his dissertation on the European balance of power in the early modern period (published in 1994) with particular attention to the problems of peacekeeping. In his habilitation on the right of subjects to resist an unjust ruler, he indicated early democratic roots of European political culture that go back to the Reformation era and are still relevant today. Since his appointment at the University of Salzburg (2007), he has intensively re-researched intercultural relations between Christian- and Muslim-coined cultures, especially the Habsburg Monarchy, the Holy Roman Empire and the Ottoman Empire in the field of diplomacy. In recent years Mr. Strohmeyer has increasingly turned to digital humanities and integrated theories and methods of computer science into his research.
