Family related transitions in adulthood have undergone profound changes in the late 20th and early 21st century. Compared to earlier generations, fewer men and women opt for parenthood altogether, and those who do usually have their children later in life. Educational expansion and the rise of educational homogamy have led to a rise in dual-earner families. Mothers thus continue to be employed upon giving birth and have fewer children altogether. In addition, institutional shifts in gender culture and family policies foster father's more active engagement in child care and more equitable divisions of unpaid work within families. Yet, housework and raising children remain time and resource intensive endeavors, leading to tensions between partners' gainful employment and family life. The talk provides an overview of these changes in comparative perspective, drawing on the research conducted by Grunow and her team in the Apparent ERC project, 01/2013-12/2016..
